October Meeting Minutes

Melissa Marshall called the meeting to order at the West Chase Marriott on November 12, 2009 at 7:40 a.m.

Melissa Marshall asked for anyone who had not yet received a ballot for the general election of the 2010 Board of Directors. Jerri Babin and Evalyn Shea ensured ballot distribution and Melissa Marshall announced the slate as follows; President – Jerri Babin, 1st Vice President – Denise Kraus, 2nd Vice President – Priscilla Gagliano, Treasurer – Lauren Grabski, Secretary – Ashley Bourgeois, Member at Large – Terri Guerrero. Evalyn Shea then took up remaining ballots for count.

Melissa Marshall made a motion to approve the October minutes as written. Lauren Grabski made a motion to approve and Peggy Vincik seconded. The minutes were approved as written with none opposed.

Melissa Marshall presented the Mission Statement for SPWP in 2010: "SPWP as an organization will strive to encourage and motivate individuals to exceed their professional expectations through leadership initiatives, team work and empowerment. Our members will be challenged to participate and expand SPWP through recruitment, retention and team work"



Melissa Marshall introduced Jerri Babin current scholarship committee chairman; Jerri Babin informed the membership that in 2009 SPWP gave 16 scholarships totaling \$60,000. The Mockler scholarship was split between two young women over four years at \$8,000 each dispersed at two thousand per year. The first Mays Memorial Scholarship, a current two-year disbursement period at four thousand per year for a total of

\$8,000 was given to a young woman who demonstrated exemplary community involvement and service, the recipient had logged over 400 service hours. The remaining 13 recipients were awarded one-year scholarship totaling \$36,000. Jerri Babin announced that the scholarship applications have already been sent out and that everything was in motion for the 2010 committee to take over in January.

Melissa Marshall introduced Kelsey Hulett the 2010 Casino Event Chairman. Kelsey announced that things were already in motion and introduced Mimi Rogers as the co-chair for the event. The event will be held at the Derek Hotel again this year and planning is currently underway. She encouraged all members to sign up and participate on the committee. The date is set for April 16, 2010 and the deposit had been sent to the Derek. Kelsey mentioned many options under consideration.

In absence of Golf Committee Chairs Melissa Marshall announced that the golf tournament had sold out and that it had made an approximate profit of \$12,200. Joan Kraus added from the floor that the pro at Windrose had said we were very fortunate to still command high participation in our tournament as most tournaments held there this year had not which they attributed to the down turn in the economy.

Melissa Marshall introduces Erica Coman 2009 treasurer to give the treasurers report. A motion was made by Peggy Vincik to approve the report as written; the motion was seconded by Joan Kraus and was approved as written with no one opposed.

Melissa Marshall introduced Terri Guerrero 2009 Member at Large who announced that our meetings would continue to be held at the Westchase Marriott and that the current breakfast prices would be held or reduced.

Melissa Marshall announced that signup sheets for current committees and social events were out and encouraged all members to participate in 2010.

Melissa Marshall announced that the Social Committee planned on an active year in 2010 after taking a break in 2009. The new committee chairman would be herself and she was very excited. She announced the first event would be the event "Girlfriends-N-Giggles" benefiting the

Fort Bend Women's Shelter. Ticket cost was approximately fifty dollars, but would be announced at the January meeting. Under the umbrella of the Social Committee a new initiative to partner newer members with older members was introduced "PAL" (Participate, Acclimate, Leave a Legacy). Melissa said we continue to get feedback from newer members not finding their "niche" within our organization, and retention of members continues to be the nemesis of the organization. It is the hope that through the partnering of members these two issues can be somewhat resolved. Melissa then asked for anyone with ideas to see her after the meeting.

Melissa Marshall announced that the December meeting is our annual Christmas celebration. The membership voted unanimously to once again adopt the "Bridge over Troubled Waters", Denise Kraus would supply their wish list at a later date. The membership also voted to do the ornament exchange with a maximum value of \$20.

Evalyn Shea came forward and announced that the Slate for the 2010 Board of Directors had been voted in unanimously.

Melissa Marshall adjourned the meeting at 8:55.

With 98 companies participating including 228 drop off sites in the Houston Community, Send One Suit Week racked up over 20,000 items for DFS Houston! Amanda moved to Houston 8 years ago from her home town San Francisco, CA. She enjoys

promoting and supporting the mission of DFS Houston through community involvement and is a member of young friends of Can Care, a non-profit for cancer victim's families.
